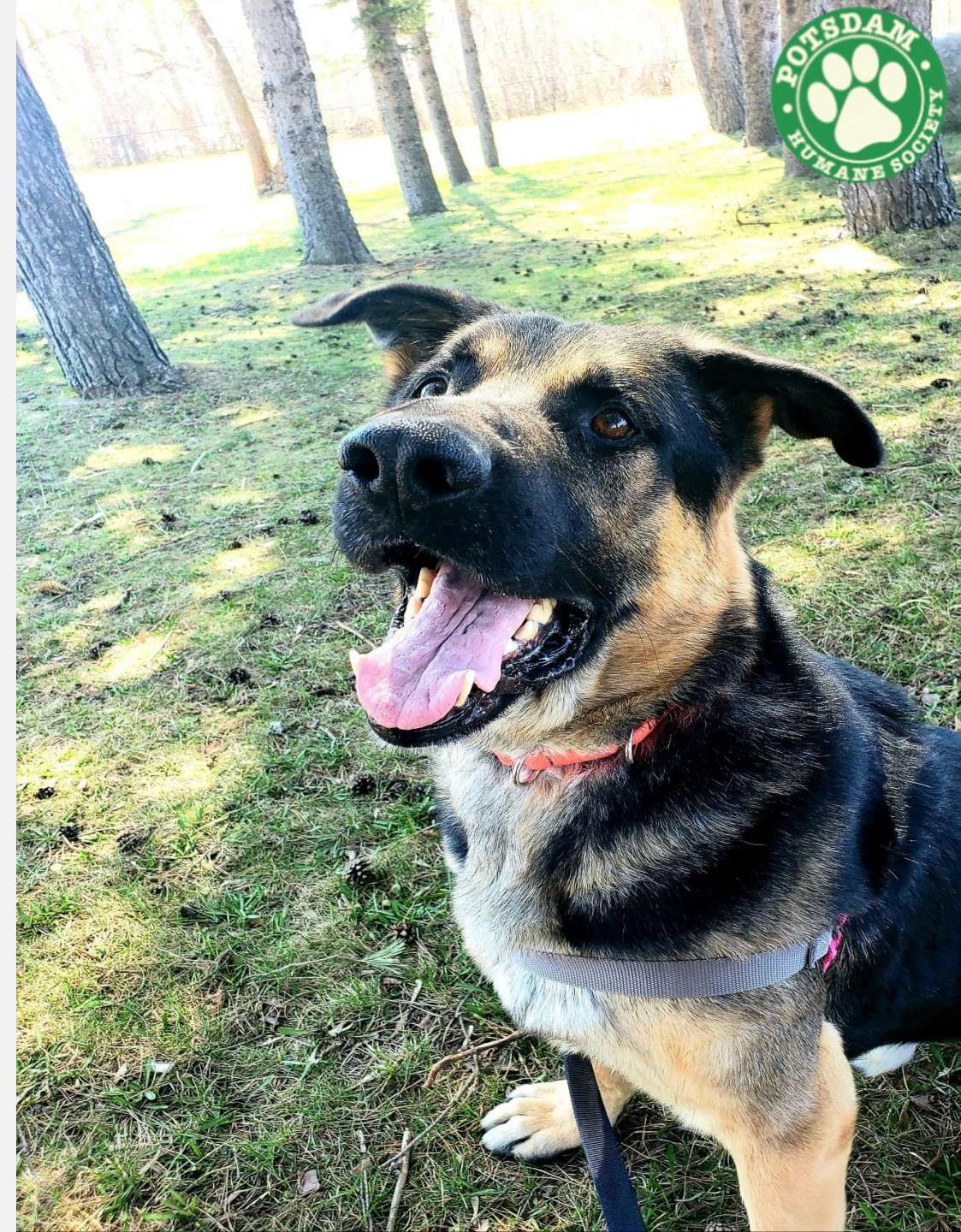
About Us

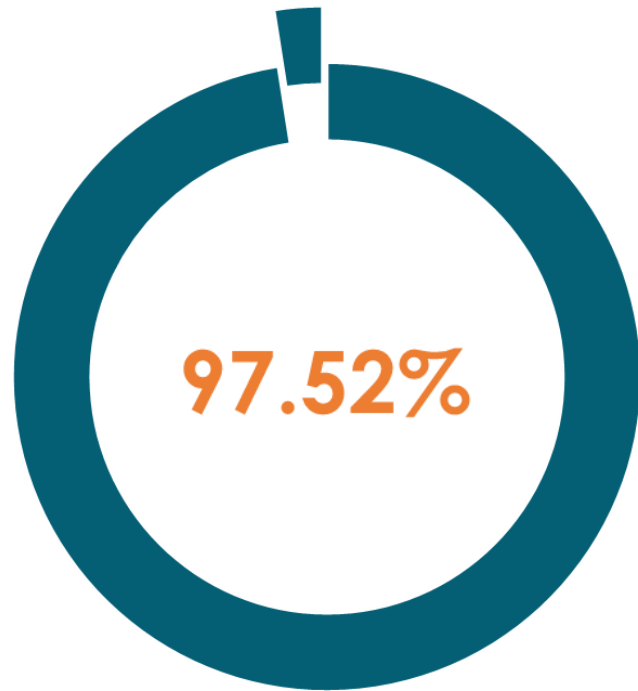
Murray (right) came to PHS as a stray, who tested positive for Heartworm in September 2019. After months long treatment, he finally met the perfect match and was adopted July 2020.

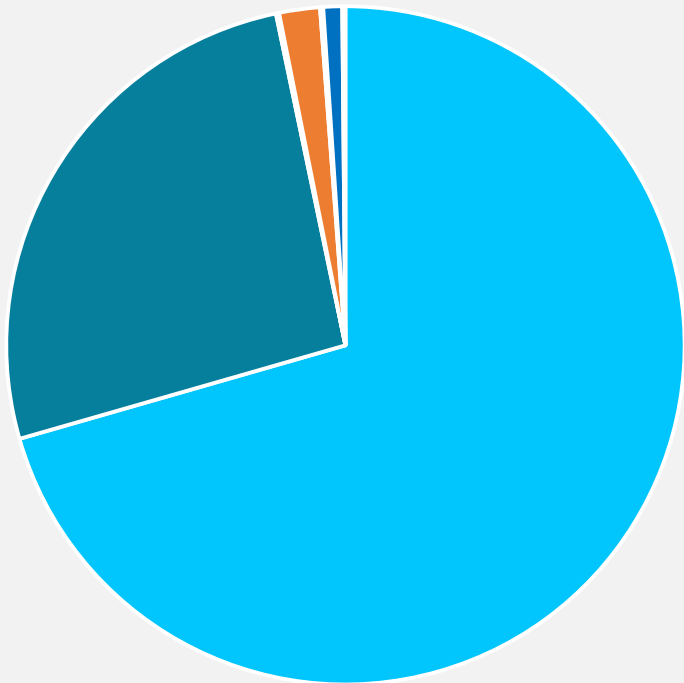

When a pet is lost, PHS provides a safe place, food, and care for the animal while we work to reunite them with their families. Thanks to you and social media, PHS was able to get **98** pets back home, which included 76 dogs and 22 cats!

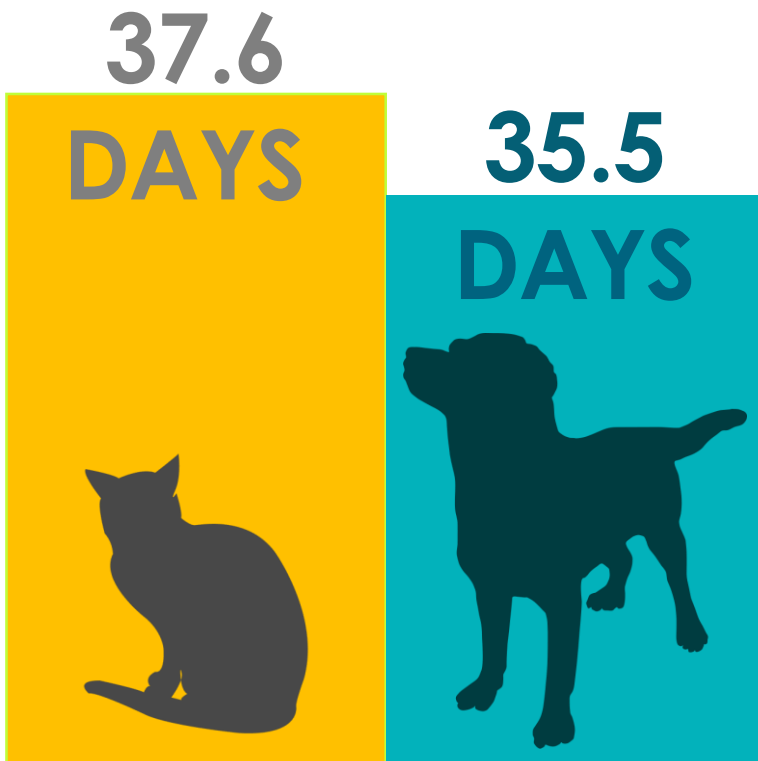
PHS performs low cost spay and neuter surgeries through our PHS Project Spay Neuter Incentive Program to low income families in the North Country. Even during the pandemic, PHS was able to provide **195** surgeries for family pets in 2020.

Spay & Neuter Surgeries

All animals that are adopted through the Potsdam Humane Society are spayed or neutered prior to adoption. Even during a pandemic, the work of the shelter did not stop. **753** surgeries were performed at Potsdam Humane Society.

Length of Stay

When an animal comes to the Potsdam Humane Society, we believe that every animal should stay just as long as they need to in order to get the care they need and be adopted into a great home without delays. For some animals, the process may be quick, for others that may be sick or injured, it is a longer journey. The average length of stay in 2020 for cats is 37.6 days and 35.5 days for dogs! This is down from 2019, as the length of stay for cats was 45 days and 39 days for dogs.

Foster Care

Potsdam Humane Society has many generous volunteers that offer up their time and home to foster animals until they can be placed for adoption. A majority of the animals are healing from illnesses or other medical issues.

From spring to fall, many families foster litters of kittens so they can grow up in a home setting instead of a cage at the shelter. PHS even has foster families for feral cats and kittens, to tame them so they can be adopted!

We are very fortunate and could not help so many animals without a great group of dedicated foster families!

Jack (right) came to PHS at just two weeks old. His mother had an emergency c-section, and he was the only puppy to survive. He went into PHS Foster Care where he was bottle fed and carefully taken care of. After about two months of foster care- Jack was a big healthy boy and ready to be adopted!

For the past few years, Potsdam Humane Society has been involved in the Funds2Orgs Shoes for Shelters Fundraiser. It is a fun way to raise money for the shelter and everyone can participate! The idea is that shoes are recycled and repurposed and given to those in need, AND the Potsdam Humane Society earns much needed funds!

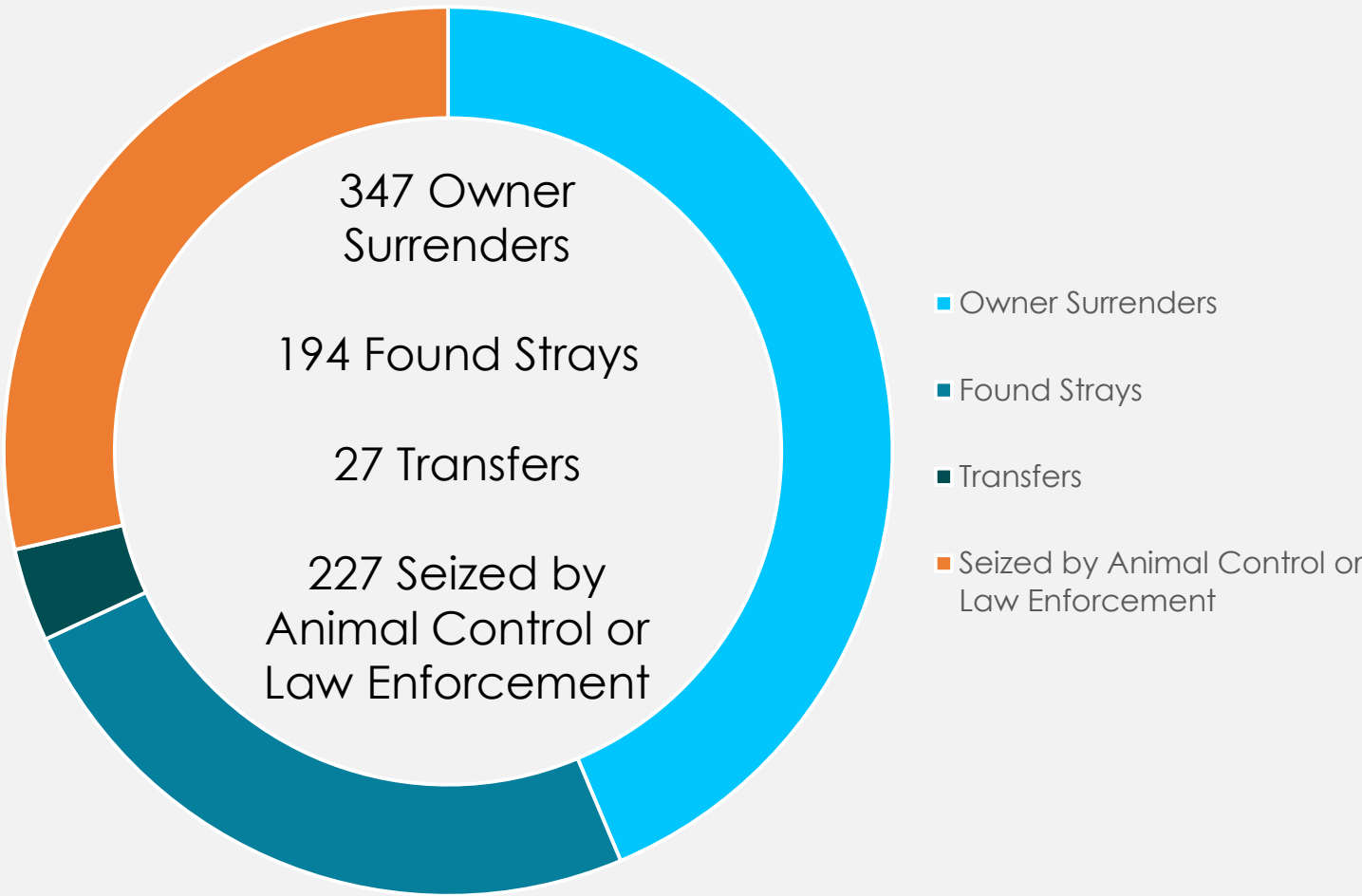

Potsdam Humane Society provides services to ten Municipalities by taking in animals that are abandoned, lost, seized, animal cruelty cases, and bite quarantines through Animal Control or Dog Control Officers.

Animal Rescue

Potsdam Humane Society contracts with ten townships to provide sheltering services for animals in need. Each town has an Animal Control Officer or a Dog Control Officer. These officers support the community with around-the-clock service. By contracting with PHS, Animal Control supports animal welfare and keeps community members safe.

Her days were spent as the "Lobby Dog" where she would work hard greeting visitors, snuggling volunteers, and trying not to snore too loud. One day, a family came to meet Chloe, and Fell In Love – but who wouldn't?! Finally after 1,064 days Chloe upgraded from her PHS home to a family and home of her very own!



Pets & Veterans Golf Tournament

Potsdam Humane Society hosted the 10th Annual Pets & Veterans Golf Tournament in August 2020 at the Partridge Run Golf & Country Club. The Tournament was the most successful to date, raising over \$12,000!

The Covid-19 pandemic put a damper on annual fundraisers for Potsdam Humane, so to host a successful fundraiser with such community support was truly a blessing.

The Tournament funds help care for the homeless animals of the North Country and support the Potsdam Humane Society's Veterans Adoption Program.

The Veteran Adoptions Program waives adoption fees for active duty or retired Military Veterans (with an approved adoption application). The motto of the Tournament is "Golf One Day- Save Two Lives".

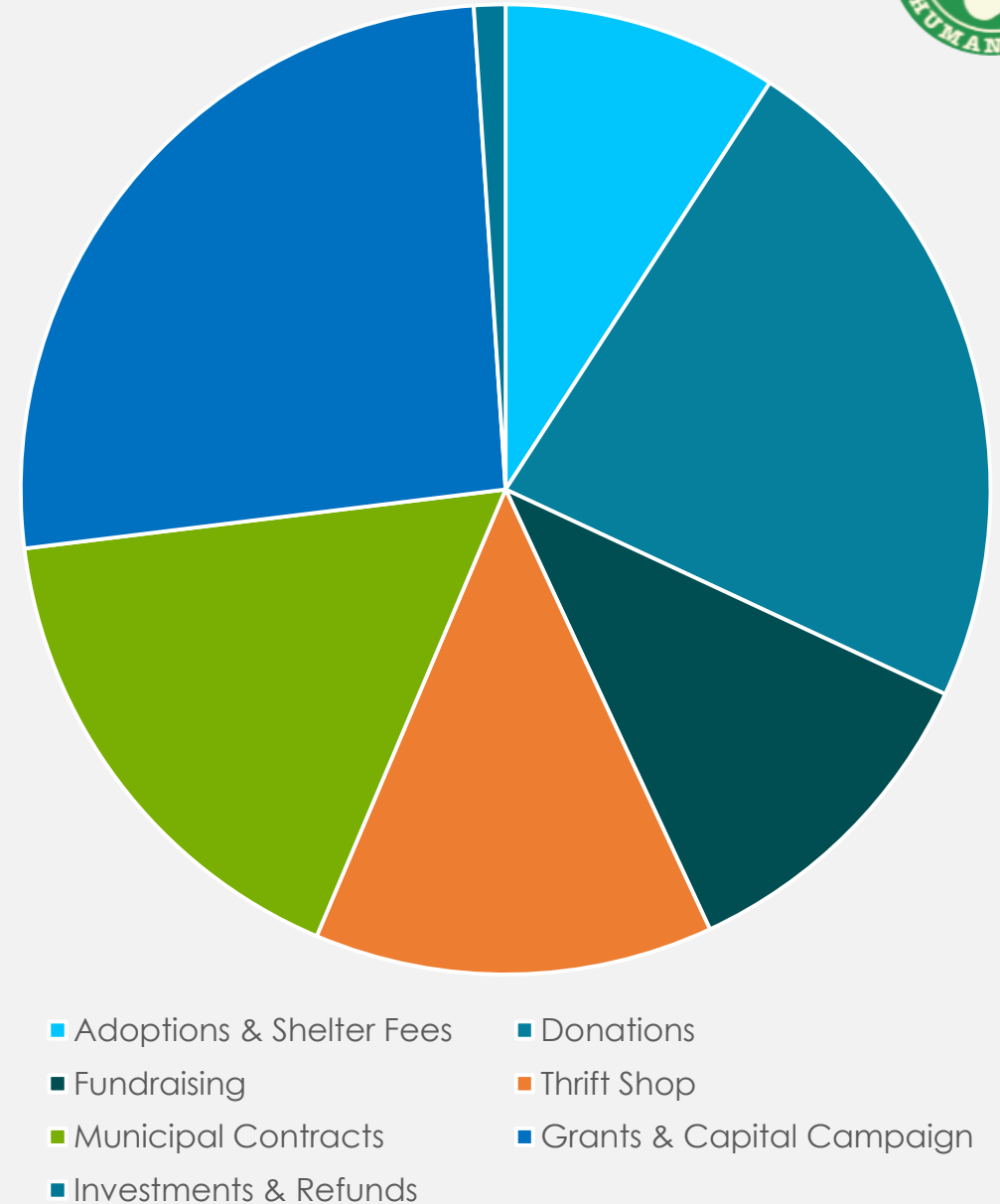

2020 Revenue



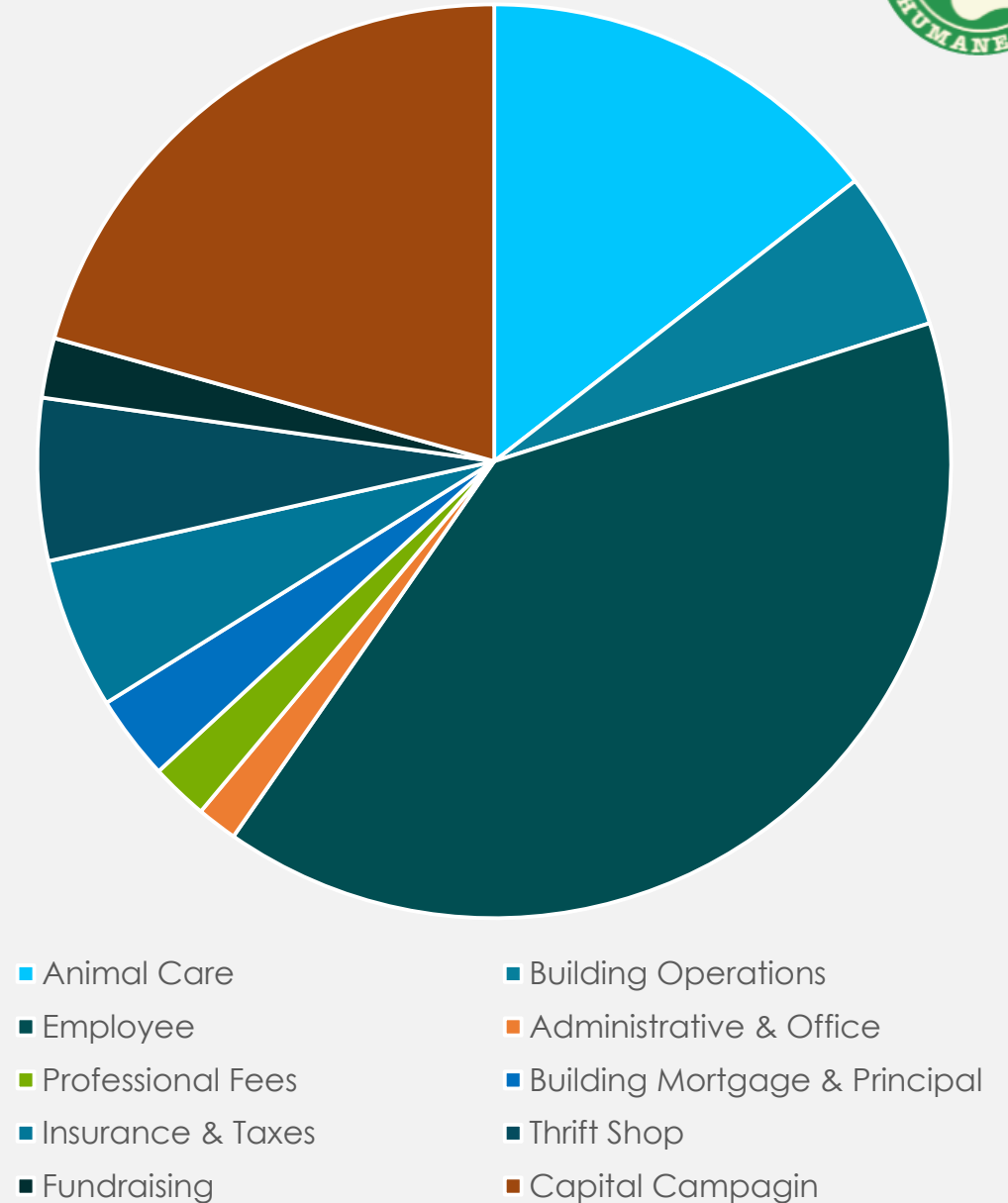
