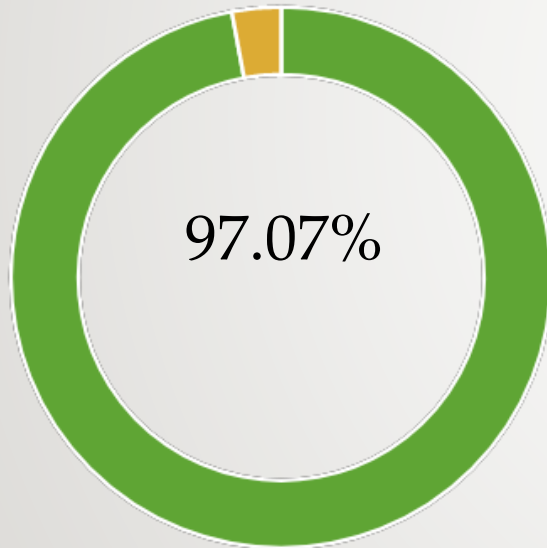

2021 Save Rate



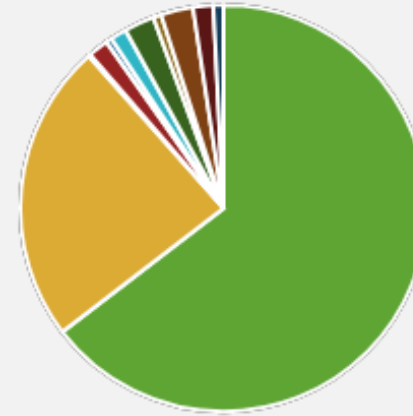

Lost & Found

When a pet is lost, PHS provides a safe place, food, and care for the animal while we work to reunite them with their families. Thanks to you and social media, PHS was able to get **78** pets back home, which included 62 dogs, 15 cats, and 1 rabbit.

Project S.N.I.P

PHS performs low cost spay and neuter surgeries through our PHS Project Spay Neuter Incentive Program to low income families in the North Country. Even during the pandemic, PHS was able to provide **180** surgeries for family pets in 2021.

Spay & Neuter Surgeries

All animals that are adopted through the Potsdam Humane Society are spayed or neutered prior to adoption. Even during a pandemic, the work of the shelter did not stop. **732** surgeries were performed at Potsdam Humane Society.

Length of Stay

When an animal comes to the Potsdam Humane Society, we believe that every animal should stay just as long as they need to in order to get necessary medical care and be adopted into a great home without delays.

For some animals, the process may be quick, for others that may be sick or injured, it is a longer journey.

The average length of stay in 2021 for cats is 46.1 days and 47.8 days for dogs! This includes their time in our “Foster to Adopt” Program, where families foster the pet to make sure it is the best fit for their family and the pet from PHS.

Foster Care

Potsdam Humane Society has many generous volunteers that offer up their time and home to foster animals until they can be placed for adoption. A majority of the animals are healing from illnesses or other medical issues.

From spring to fall, many families foster litters of kittens so they can grow up in a home setting instead of a cage at the shelter. PHS even has foster families for feral cats and kittens, to tame them so they can be adopted!

We are very fortunate and could not help so many animals without a great group of dedicated foster families!

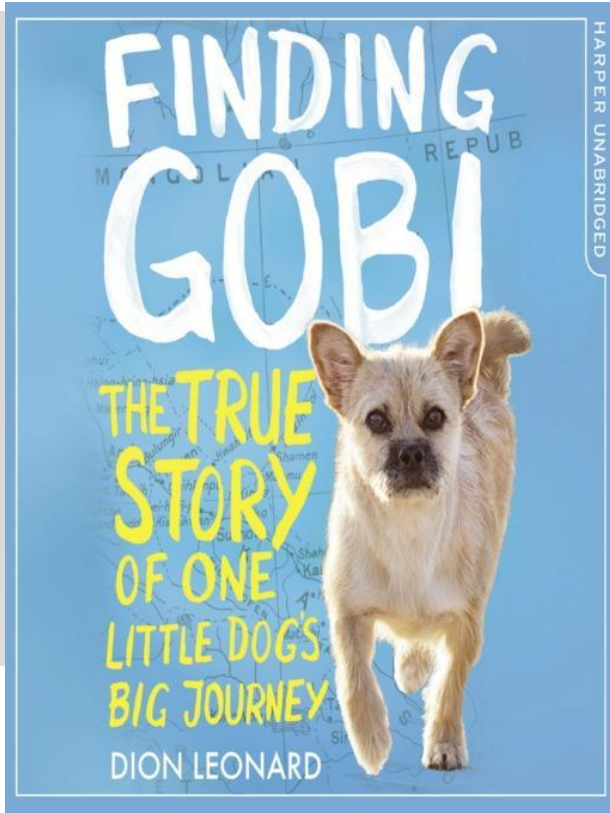

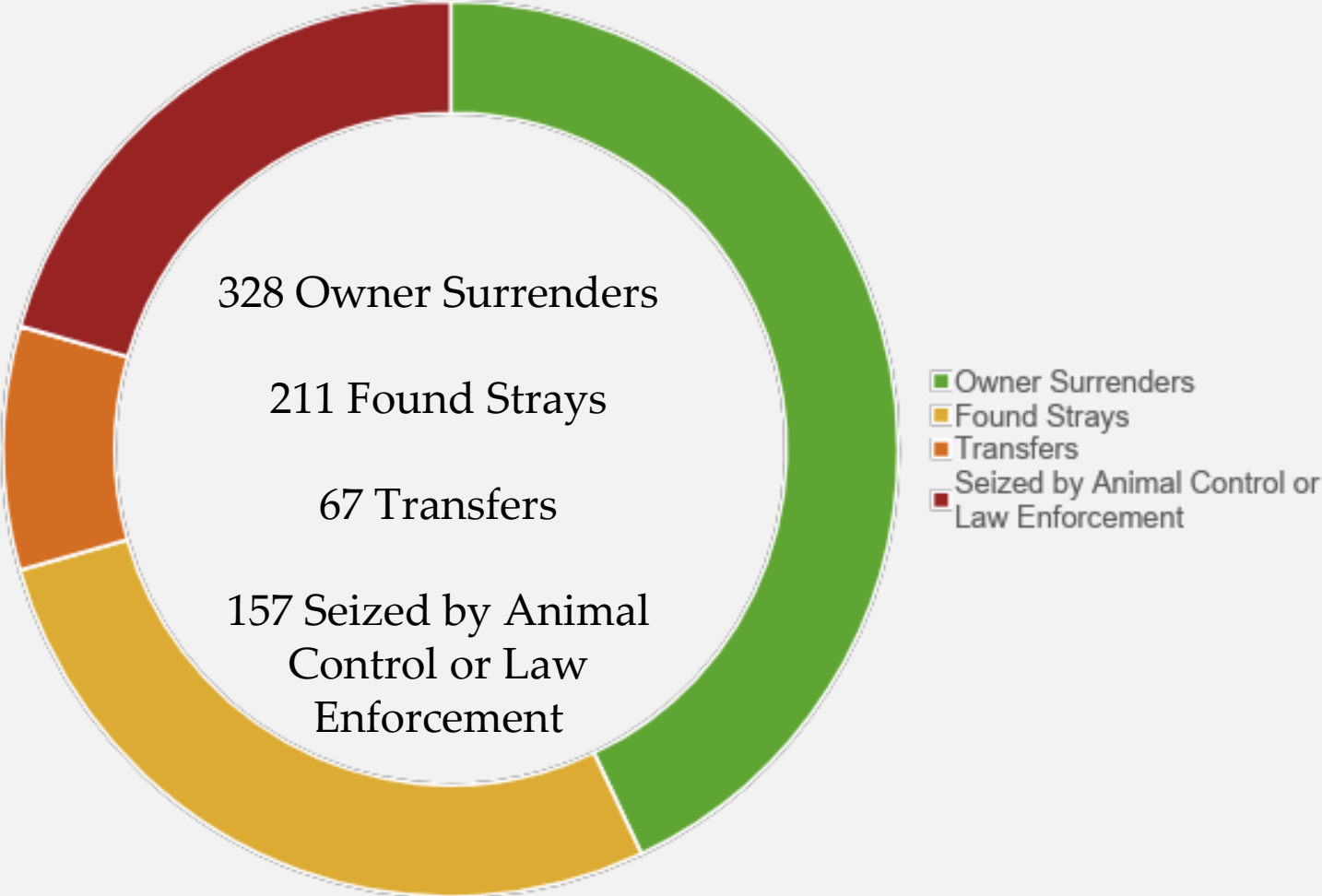

The Potsdam Junior Hockey League hosted a Mite Day, where Potsdam Mites and other invited local teams donated items and goodies for the PHS shelter animals.

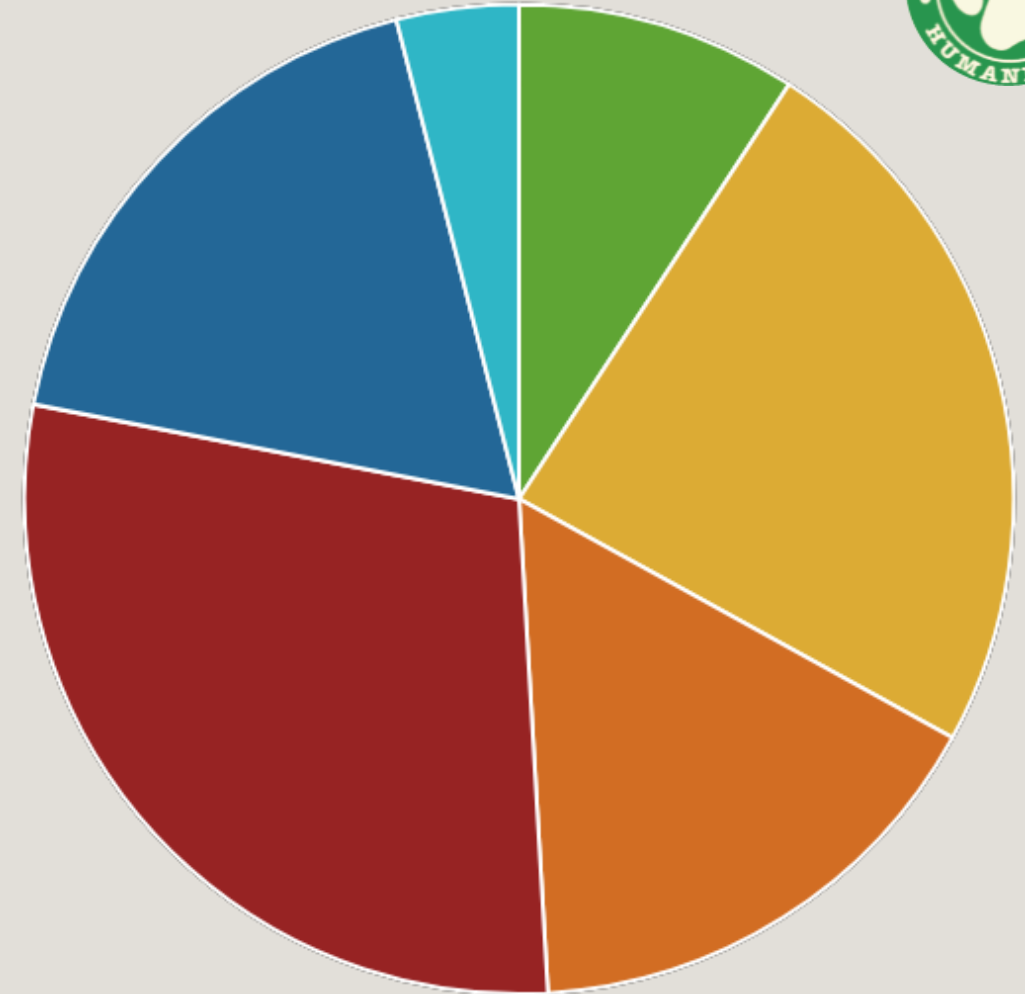

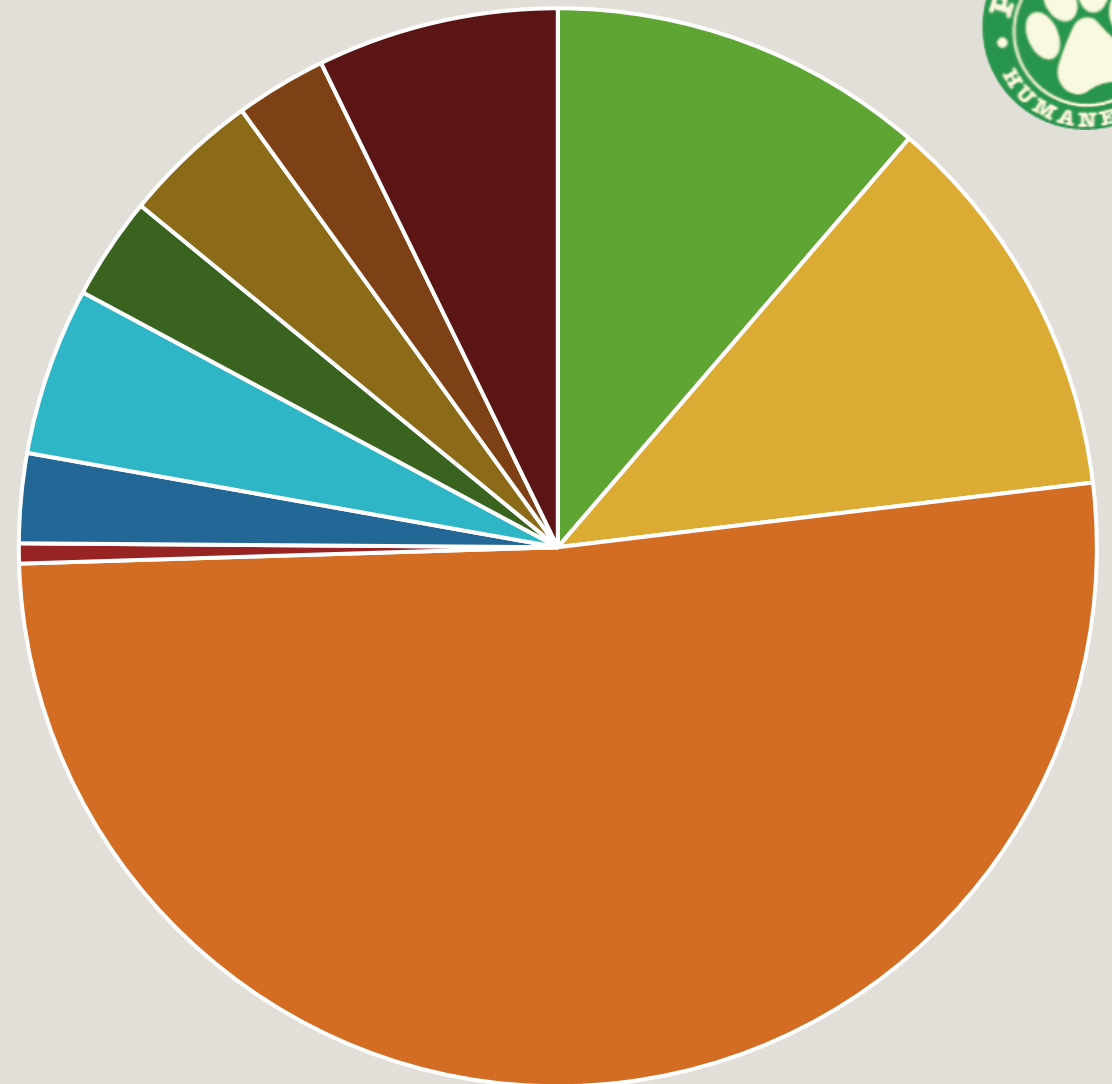
